

Annual Seventh Grade Trip to Florida

Who: All seventh grade students and parents

When: Wednesday, March 4 through Friday, March 6, 2015

What: An exciting, fun and educational trip to Florida that will include stops at St. Augustine, Islands of Adventure, and the Kennedy Space Center.

Cost: \$525 per student/adult. This price is based on four people to a room. There will be an additional charge for two people in one room. This price is also subject to the number attending – you will be notified if this changes; however, I do not anticipate that happening, so you should be able to plan on this price.

The seventh grade class will be going to Florida. We will leave Wednesday, March 4 in the morning and return late on Friday, March 6. We will be traveling on a DVD equipped chartered bus. We will head to St. Augustine Florida and tour the oldest fort in the continental United States, the Old Jail of St. Augustine, and the city. After the tour, we will depart St. Augustine and head to Orlando where we will stay for the next two nights. We will enjoy dinner out and then go watch the famous Blue Man Group. On Thursday, March 27 we will spend the day at Universal's Islands of Adventure. On Friday, March 28 we will depart Orlando and visit the Kennedy Space Center Visitor Complex where we will learn about the NASA space program, watch IMAX movies and tour the facilities and rockets. We will depart the space center and arrive back in Milledgeville late Friday night.

The total cost of the trip will be \$525.00 (price is contingent on number going as mentioned above). The price includes the bus, hotel for two nights, five meals (lunches are not included), and admissions to the sights in St. Augustine, Blue Man Group, Islands of Adventure, and Kennedy Space Center. Please reserve a place for your child and any members of your family by **completing the information below** and returning it to the school along with a **\$75.00 non-refundable** deposit by **Friday, November 7, 2014**. <u>All checks must be made payable to JMA.</u> Also, please return the attached Field Trip Permission Form.
